Dogs & Cats Aged 13 years and over – no fee payable, but still required to be registered with Council

All cats & dogs must be registered by 3 months of age – Failure to Register Penalty - \$330.00

EXCESS ANIMAL PERMIT

If you have more than the maximum animals permitted, permits are available at the Yarriambiack Shire Council Office located at 34 Lyle Street, Warracknabeal. Cost of the permit is \$50, this permit will remain in effect for 2 years from the date of issue.

Townships – 2 Dogs and 3 Cats
Rural Areas – 5 Dogs and 5 Cats

RESPONSIBLE PET OWNERSHIP

- Ensure your Dog and Cat ARE wearing their tag.
- Dogs and Cats not used for breeding should be desexed.
- Confine your animal to your property. Keep your Dog on a leash whenever outside the property.
- Cats should be kept indoors between sunset and sunrise.
- Remember to carry a suitable bag to Stoop and Scoop and clean up after your Dog.
