Registration Period: Registrations are due on 10th April every year.

Permits for Multiple Pets: Under Council's Local Law Section 22(1), It is an offence to keep more than two (2) dogs or three (3) cats on a township property without a permit, unless in a rural setting, where up to five (5) dogs and five (5) cats can be kept.
