4. Claims

The Conveyor will be sold “**as is**” and no claims will be entertained that the Conveyor is not as it was at the time the offers closed.

5. Payment

A tax invoice will be issued to the successful tenderer for payment; payment must be made to Council **before** the Conveyor is removed by the successful tenderer.

6. Removal of the Item upon Awarding of the Tender

The successful tenderer must arrange for the removal of the Conveyor within 21 days of notification by Council their offer has been accepted (noting that payment in full must be made prior to removal).

The successful tenderer will be required to liaise with either La Vergne Lehmann or Adam Moar to schedule a mutually convenient date/time to collect the Conveyor from the Transfer Station.

You will be required to provide a copy of your proof of payment upon collection.
