16 Special Conditions:

- i. The Lions Club is to undertake daily welfare duties of all animals located on the Reservation.
- ii. The Lions Club is to undertake mowing, general tiding and basic maintenance on the Reservation. This includes minor repairs and maintenance to all enclosures.
- iii. The sprinkler system is the responsibility of the Lions Club, including repairs and maintenance.
- iv. The BBQ is the responsibility of the Lions Club, including repairs and maintenance.

- The Lions Club must ensure an Emergency Evacuation Plan for animals housed v. within the enclosures is reviewed and revised annually. This Plan is to be submitted to the Shire Council annually.
- Yarriambiack Shire Council will support the Lions Club with general maintenance, vi. such as monitoring the bins and disposing of rubbish.
- Yarriambiack Shire Council will undertake the annual playground inspections, and vii. weekly visual inspections.
- viii. Yarriambiack Shire Council is responsible for the car park, including maintenance and repairs.
- Yarriambiack Shire Council is responsible for maintenance and repairs of the Toilet, ix. Shade Sail. Playground and Rotunda.
- Any capital works and structural improvements are to be approved by Council as the X. Land Manager with consent from DEECA for funding applications and works as Land Owner. Requests for financial assistance are to go through the annual budget process, and are to be submitted to the Chief Executive Officer in writing by the 15 March each year. Budget submissions are not a guarantee of funding.
- Yarriambiack Shire Council encourages the Lions Club to apply for Council Share xi. Grants and funding opportunities for improvements to the Park. All funding applications will require a letter of support from Council as the Land Manager.
- xii. Yarriambiack Shire Council will clean the toilets at the Lions Park.
- xiii. Yarriambiack Shire Council insurance will cover building structures on the Reservation, including Toilet, Shade Sail. Playground, Rotunda, and BBQ.
- xiv. Yarriambiack Shire Council insurance does not cover the animals or the animal enclosures, which is required to be separately insured by the Lions Club. The Lions Club is responsible for the maintenance and upkeep of the animal enclosures.
