#2 THERE IS PRESENTLY A DOG WANDERING IN THE AREA, WITHOUT A HUMAN IN SIGHT, ON MANY OCCASIONS – A BLACK DOG OF A GOOD SIZE – WHICH I THINK COMES FROM THAT ADDRESS. IF IT IS THEIRS THEN THEY ARE NOT PRESENTLY CONTROLLING WHAT THEY HAVE – HOW DO THEY PLAN ON CONTROLLING MORE DOGS?
