If you choose to inspect the vehicle, it will be mandatory to be accompanied by a Council officer and to sign a register prior to viewing the vehicle. You will be supplied with a Hi-Vis vest, which you will be required to wear at all times while on-site.

3. Claims

The vehicle will be sold “as is” at the time of inspection and no claims will be entertained that any part or parts of the vehicle have deteriorated more than anticipated or that the vehicle is not as it was at the time the offers closed.

4. Payment
